WHAT'S NEW? PILOT IMPLEMENTATION

The goal of the NETworks4inclusion project is to establish a dynamic collaboration between public and private entities to foster societal progress and enhance social cohesion.

Our first step in achieving this was through the creation of the NETWorks4Inclusion Guide for Social Inclusion. The Guide for Social is an innovative, dynamic, and participatory instrument, that can help relevant target groups understand the social reality across Europe and improve communication between different entities and social actors working on education, employment, and social inclusion policies.

TRANSNATIONAL PARTNERSHIP MEETING 2



The second Transnational Partner Meeting for NETWorks4Inclusion took place in Assen, The Netherlands, on September 28th, 2023. The primary agenda of this meeting revolved around deliberating the progress of the NETWorks4Inclusion project and the ongoing development of project resources. Furthermore, partners had the opportunity to explore the **NETWorks4Inclusion E-Learning Portal** and to make preparations for the upcoming Learning, Teaching and Training Activity scheduled for July 2024 in Italy. The Networks4Inclusion consortium is also planning another transnational meeting. This will take place in France in September 2024.

Project partners have piloted the Guide for Social Inclusion with over 30 relevant individuals. This aims to support adult educators, community workers and those working with individuals in vulnerable situations across France, Italy, Portugal, Germany, Ireland, The Netherlands and Spain.
